1. Number of post/vacancies is tentative and the recruitment process can be cancelled/suspended/terminated by the appointing authority at any stage, due to administrative reasons.

2. Online Application Form, Educational and other qualifications and Age Limit.

(a) **Online Application Form**:- (i) Only online application will be accepted. (ii) Online application with mandatory undertaking/forms to be uploaded by the candidate is available at <https://cmepune.edu.in>. (iii) Candidates should NOT send any application printouts or certificates or copies to CME by post. (v) Any future amendments / corrigendum in the advertisement will be published in <https://cmepune.edu.in>.

(b) **Age Limit.** All four vacancies are for SC and ST as given in the table above. The age criteria for appointment as LDC in Unreserved category is 18 to 25 years and 40 years for departmental candidates. Age relaxation for candidates from SC & ST categories is 5 years from the upper age limit ie upto 30 years and 45 years for SC & ST departmental candidates details of which are available at <https://cmepune.edu.in>. The crucial date for determining age limit shall be the last date for receipt of application.

(c) **Last date of submission of online application**: - (i) The last date of receipt of online application at <https://cmepune.edu.in> is 10 Sep 2023. (ii) Candidates are responsible for providing all factually correct data and correct certificates/documents. Providing factually incorrect data, fake certificates/documents or providing incomplete certificates / documents by the candidate will result in automatic rejection of his/her candidature.

(d) Persons working in Central Govt /State Govt /PSUs must also forward a printout of the application through the competent authority of his/her present organisation to Recruitment Cell, F CBRNP, CME, Dapodi, Pune-411031 is 19 Sep 2023. Admit Card will not be issued in case of non-receipt or late receipt of copy of the applications at CME, Pune.

3. Screening, Written Test and Skill/Practical Test.

(a) Mere submission of online application(s) does not entitle candidates to be called for the written test.

(b) The number of candidates to be called for the written test will be restricted as per the merit of the candidate in the educational and other qualifications required. The number of candidates being called for the skill / practical test will be restricted.

(c) Both Written and Skill/Practical tests will be carried out.

(d) Shortlisted candidates will be intimated later via email on their registered email ID about the status of their application. The organisation will not be responsible for non-receipt of intimation due to inactive / incorrect email ID. The candidates should check their status and shortlisted candidate should download their Admit Card **approx 10 days** after the last date of submission of the application from <https://cmepune.edu.in>.

(e) No extra weightage will be given to additional qualifications / experience other than those mentioned above.

(f) Syllabus for written test alongwith breakdown of marks has been provided in detail on <https://cmepune.edu.in>.

(g) The examination centre will be in Pune, Maharashtra.

(h) Candidates will be responsible for their meal, travel and accommodation arrangements for the written test and skill / practical test. No TA/DA will be provided.

(j) For the written test and skill / practical test, candidates are required to carry blue / black ball point pen only.

(k) The candidates must always wear mask, use sanitizer, maintain social distancing at examination centre and strictly follow the Covid-19 guidelines.

(l) Candidates are required to report for the written test, skill/practical test with identity proof (Passport, Aadhaar Card, PAN Card, Driving License & Voter's I Card) and Admit Card for confirmation.

4. Mode of selection.

(a) All applications will be scrutinized in terms of age limit, educational and other qualifications as given above, and documents, forms and certificates uploaded by candidate on <https://cmepune.edu.in>.

(b) The shortlisted candidates will be required to appear for the written and practical tests. The written test will be of Objective Type of multiple choice questions of 12th standard.

(c) The written test will consist of (i) General Intelligence & Reasoning (ii) Numerical Aptitude (iii) General English (iv) General Awareness.

(d) The question paper will be in English and Hindi except for General English paper.

(e) The requisite number of candidates will be shortlisted and called for skill / practical test based on merit in the written test. The candidates should check their status and shortlisted candidate should download their Admit Card from <https://cmepune.edu.in>.

(f) The skill/practical test being only qualifying in nature, final selection of the candidates will be based on marks obtained by the candidates in the written test subject to qualifying in skill/practical test.

5. The decision of appointing authority regarding selection / rejection will be final.

6. Candidates on selection are liable to be transferred anywhere in India.

7. To avoid last minute rush, candidates are advised in their own interest to submit ONLINE applications well before the closing date since there may be a possibility of inability / failure to log on to the website on account of heavy load on the internet or website jam during last days.
