Selection will be based on the qualification, experience, and Interview.

2	Documents Required	Applicant should bring all original certificates including mark sheets (matriculation onwards), experience certificate(s), monthly emoluments/salary drawn, and other relevant documents (including one set of self-attested certificate /document, updated Curriculum Vitae, publication, and filled-in application form.

## **General Instructions to the applicants:**

- 1. Applicants are advised to ensure that they possess the minimum essential qualification and experience laid down for the post before appearing for Selection Process. Qualification obtained has to be from a recognized University/Institute. Eligibility in terms of age, qualification, and experience of a candidate shall be considered as on the last date for receipt of application.
- 2. Selected candidates shall not have a claim on any regular position. They shall not be bestowed any of the privileges like Housing, Medical Facility and Other benefits available to regular employees of the Institute.
- 3. No TA/DA will be paid for attending the Interview.
- 4. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of the appointment letter, the Institute reserves the right to modify, withdraw or cancel any communication made to the Applicants.
- 5. After joining the service of the Institute, the person will have to abide by the Rules, Regulations, Ordinances, Statutes, and Act of the Institute applicable from time to time. He/She may be assigned any duty within or outside the Institute depending upon the exigency of the work.
- 6. The Institute shall verify the antecedents or documents submitted by a person at the time of appointment or during the tenure of the service.
