TRAINING, EMOLUMENTS & PLACEMENT

Diploma Trainee:

Selected candidates will undergo training for a period of two years at any of the NTPC project's EDC/ RLI during which they will be paid a consolidated stipend of Rs. 24,000/- per month. On successful completion of training these candidates will be absorbed in the payscale of W7 Grade.

Artisan Trainee/ Asst Material /Storekeeper Trainee:

Selected candidates will undergo training for a period of two years at any of the NTPC project's EDC/ RLI during which they will be paid a consolidated stipend of Rs. 21,500/- per month. On successful completion of training these candidates will be absorbed in the payscale of W3 Grade.

Candidature to be drawn from permanent residents of Bodoland Territorial Region (BTR) comprising - Kokrajhar, Baksa, Chirang, Udalguri districts of Assam.

The candidature to the aforesaid vacancies shall be drawn only from permanent residents of Bodoland Territorial Region (BTR) who shall have to produce valid Permanent Resident Certificate (PRC) in original during the selection process.

- 1. Diploma Engineer Trainee- Course must be approved by Board of Technical Education (BTE)/ State Technical Education Board.
- 2. ITI Trainee- Course must be approved by NCVT/ SCVT.
- 3. Full Time Regular Course is required for Both Diploma Engineer Trainee and ITI Trainee. Candidates/Applicants who have acquired Diploma/ITI qualification through Distance Learning Mode shall not be eligible.

SELECTION PROCESS:

Diploma Trainee

Eligible candidates will have to undergo 2 stage On-line test consisting of:

In first stage, Aptitude Test consisting of 120 questions covering General English, Quantitative Aptitude and Reasoning will be conducted which will be qualifying in nature.

In 2nd stage, Technical Test consisting of 120 questions in the respective discipline will be conducted for shortlisted candidates of stage 1. The Offer of appointment will be issued based on merit of stage 2(Technical knowledge test).

The duration of written test will be 2 hours each. There will be negative marking for wrong answers (Each question carries one (1) marks. 0.25 marks will be deducted for every wrong answer).

The qualifying marks is 40% marks in case of General/EWS category and 30% in case of SC/ST/OBC/PWBD. The merit list will be prepared of only those candidates who score equal to or more than qualifying marks.

ITI Trainee/ Asstt Material/ (Storekeeper) Trainee

Eligible candidates will have to undergo single stage, 2 part online test consisting of:

Part I - Knowledge test which will consist of 70 multiple choice questions on technical subject from relevant discipline as advertised.

Part II- Aptitude test which will consist of 50 multiple choice questions comprising English, Quantitative Aptitude and Reasoning.

The duration of written test will be 2 hours. There will negative marking for wrong answers. (Each question carries one (1) marks. 0.25 marks will be deducted for every wrong answer).

The candidates are required to qualify both in Technical Knowledge Test and Aptitude Test. For General/EWS category candidates, the qualifying marks for Technical Knowledge Test and Aptitude Test are 40% and 30% respectively. There is a relaxation of 25% in qualifying marks of written test in both Technical Knowledge Test and Aptitude Test for SC/ST/OBC/PWD candidates.

Skill Test: For selection to the Artisan Trainee there will be a skill test of those candidates who have qualified in written test. The skill test will be of qualifying nature only. Assessment will not be done on the basis of marks of skill test. The qualifying marks for skill test is 40% marks in case of General/EWS category and 30% in case of (SC/ST/OBC/ PWBD).

The final merit list will be prepared based on the marks of the written test, for those candidates who will qualify in the skill test.

Test Centre: Test Centre shall be communicated to candidates at the time of issuance of Admit card.

- Reservations and relaxations for SC/ST/OBC (non-creamy layer)/ XSM / EWS/ PwBD (degree of disability 40% or above) candidates will be provided as per Government guidelines. Relaxations will be extended in vacancies identified for SC/ST/OBC (non-creamy layer)/XSM/PwBD candidates. Category once filled in the online application form will not be changed and no benefit of other category will be admissible later on.
- 2. The reserved category candidates are required to submit requisite valid certificate in the latest prescribed format of Government of India, issued by the competent authority.
- 3. The upper age limit is relaxed by 5 years for SC/ST, 3 years for OBC candidates. It is relaxed by 10 years for PwBD-General/EWS, 13 years for PwBD-OBC and 15 years for PwBD-SC/ST candidates. The OBC candidates who belong to "Creamy Layer" are not entitled for concession admissible to OBC category and such candidates will have to indicate their category as General. Age relaxation will be applicable for Ex-Servicemen as per Government Guidelines. The EWS/SC/ST/Disability certificate/OBC (Non-Creamy Layer)/Ex-Serviceman candidates are required to submit a valid requisite certificate in prescribed format of Government of India, from a competent authority at the time of joining as per prescribed rules.

SERVICE AGREEMENT BOND:

The selected candidates for Diploma Trainee will be required to execute a service agreement bond of Rs 100,000/- (General, EWS and OBC) and Rs 50,000/- (SC/ST/PWBD) to serve the company for a minimum period of 3 years after completion of training.

The selected candidates for Artisan (ITI) Trainee / Assistant Material / Storekeeper Trainee will be required to execute a service agreement bond of Rs 50,000/- (General, EWS and OBC) and Rs 25,000/- SC/ST/PWBD) to serve the company for a minimum period of 3 years after completion of training.

HEALTH:

Before joining, candidates will have to undergo medical examination by the NTPC Medical Board and the decision of the board will be final and binding. No relaxation in health standards is allowed. Detailed medical norms are available on the application portal.

HOW TO APPLY:

- 1. Eligible Candidates need to apply online through online registration system of NTPC Only. To apply visit website (careers.ntpc.co.in) with your valid email id. The site is functional from XXXXXX till XXXXX.
- 2. Candidates will be required to upload their passport size photograph, signature, pay-in slip(if applicable) and other relevant documents during online application.
- 3. Candidates belonging to General/OBC/ EWS category are required to pay a non-refundable registration fee of Rs. 300/-. The <u>SC/ST/PwBD/XSM/ category and female candidates need not pay</u> the registration fee. The registration fee payment shall be made through **offline mode.**

Fee Payment mode: State Bank of India has been authorized to collect the registration fee, in a specially opened account (No. 30987919993) at CAG branch, New Delhi, (Code:09996) on behalf of NTPC. Candidate has to approach the nearby SBI branch with a printout of the "pay-in-slip" which is available on the application portal. The pay-in-slip printed from the portal should only be used for depositing the fee for proper crediting of amount in the allocated account. On receipt of the money, the bank will issue a unique Journal Number and a Branch Code of the bank collecting the money. This journal number and the branch code are to be filled up by the candidate during online application. Bank commission charges will be borne by the candidate. NTPC will not be responsible in case the candidate deposits the fee in a wrong account.

Candidates are informed that scanned copies of pay-in slip (applicable for candidates from General/OBC/ EWS category only), along with details of payment are required to be uploaded at application portal while applying for the post.
