Government Ayurvedic College, Warangal (Multi Zone – I) with a consolidated pay of Rs. 60,000/- ( Rupees Sixty thousand only ) per month for Professor and Rs. 50,000/- ( Rupees fifty thousand only) per month to Associate professor under the control of Director, Department of AYUSH, Secunderabad, Telangana State.

**1. Fee and submission of Application:**

The fee prescribed for applying to the post of Professor & Associate Professor (Ayurveda) on contract basis per specialty is Rs.600/- (Rupees Six Hundred Only) towards Demand Draft in the favor of Accounts Officer, Department of AYUSH, T.S., Secunderabad, between 23/09/2023 to 29/09/2023 and submit the application at O/o. the Director, Department of AYUSH, Secunderabad, Telangana State.

## **2. EDUCATIONAL QUALIFICATIONS:**

- i "Must Possess a Post Graduate Degree in Ayurveda, awarded by any University in India established or incorporated by or under Central Act or an Institution recognized by the University Grants Commission or any Statutory Board of State Government" in the concerned specialty /Allied as per the existing National Commission for Indian System of Medicine Norms".
- ii Must be a permanent Registered Medical Practitioner within the meaning of law for the time being in force in Telangana State.

### **Experience for Professor:**

*Ten Years of Teaching experience as Regular Teacher in the concerned subject or Five years teaching experience as Associate Professor (Reader) on regular basis in the concerned subject.*

### **Experience for Associate Professor:**

*Five years teaching experience as Regular Teacher in the concerned subject.*

## **3. AGE:**

Max age limit is below 65 Years as on 01/07/2023 as per NCISM norms.

## **4. GENERAL PROVISIONS:**

1. Applicant must compulsorily fill-up all relevant columns of the application and submit application at O/o. the Commissioner, Department of AYUSH, Secunderabad. The particulars made available in the application shall be processed and the eligibility decided in terms of the notification.
2. The applications received in the prescribed proforma within the time shall only be considered and the Department will not be held responsible for any kind of discrepancy.
3. Applicants must attach his/her own recent passport size photo and signature across it.
4. The applicants should not furnish any particulars that are false, tampered, fabricated or suppress any material information while making an application.
5. All the original essential certificates issued by the competent authorities of the Telangana State shall compulsorily be kept with the applicants to produce as and when required to do so. Failure to produce the required certificates on the day of verification will lead to disqualification.
6. The persons already in Government Service / Autonomous bodies/ Government aided institutions etc., whether in permanent or temporary

capacity or as work charged employees are however required to inform in writing to their Head of Office / Department that they have applied for this recruitment.

7. Residence Certificate will not be accepted, if a candidate has studied in any educational institution up to S.S.C. or equivalent examination, such candidates have to produce study certificates invariably. The candidates, who acquired Degree from Open Universities without studying SSC/Matriculation or equivalent in Educational Institutions only, have to submit Residence Certificate. Educational institutions means a recognized institution by the Government / University / Competent Authority. The Open school students must invariably enter the residence particulars in the Application form

## **7. METHOD OF SELECTION:**

Professor & Associate Professor (Ayurveda).

- (i) Aggregate of marks obtained in all the *UG & PG Degree exam (BAMS)*.
- (ii) Teaching Experience in concerned subject.
- (iii) Departmental Selection Committee will select the candidates through interview
- (iv) Candidates selected and appointed will be governed by the rules of Government regarding service conditions, emoluments, eligibility criteria and all other matters connected with service.
- (v) Preference will be given to the candidates who have already worked in Government Service as Teaching Faculty.

## **8. INSTRUCTIONS TO CANDIDATES:**

- 1) The candidate must note that his/her selection for counselling is strictly provisional. The mere fact that calling for counselling does not imply that his/her candidature has been finally cleared by the department or that the entries made by the candidate in his/her application have been accepted by the department as true and correct

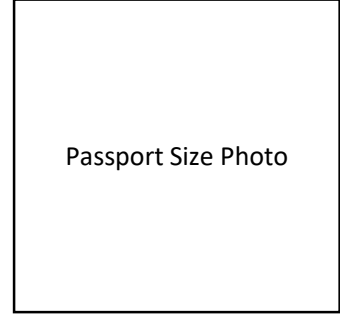

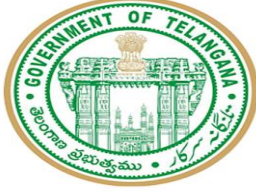

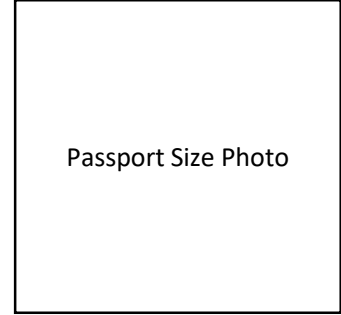
