## Please note that:

- a) The process of Registration of application will complete only when intimation charges / fees is deposited with the Bank through on-line mode on or before the last date of intimation charges / fees payment.
- b) Before applying, candidates are requested to ensure that they fulfil the eligibility criteria for the post as on date of eligibility.
- c) Candidates are advised to regularly check the Bank's website <a href="https://www.eximbankindia.in">www.eximbankindia.in</a> for details and updates.
- d) Online examination will be conducted in the following cities: Ahmedabad, Bangalore, Bhopal, Bhubaneshwar, Chandigarh / Mohali, Chennai, Delhi / NCR, Guwahati, Hyderabad, Kolkata, Lucknow, Mumbai / Navi Mumbai / Thane / MMR region, Nagpur, Patna, Raipur, and Ranchi. The examination centres might change / merged if enough candidates are not available. Interviews will be held at <u>Mumbai</u> and / or **New Delhi**.
- e) Selected candidates may be posted in Bank's offices anywhere in India, as per its discretion and requirement.

- f) Candidates who have appeared for the final examinations and waiting for the results are eligible to appear for the written examination. However, the offer to join the Bank shall be subject to production of necessary documents evidencing successfully obtaining the requisite qualification by April 01, 2024, or joining date as prescribed by the Bank (whichever is later). The date mentioned on their degree / final marksheet shall be reckoned for arriving at their eligibility within the specified timelines, i.e., June 01, 2024.
- g) Candidates can apply for only one post. If a candidate applies for more than one post, only the latest valid (completed) application/registration (higher registration number) will be retained, and the application fees /intimation charges paid for the other multiple registration(s) will stand forfeited.

- Candidates must state their reservation status clearly in the application. Applicants should produce in original their degree certificates, caste, experience, and any other relevant certificates at the time of interview/ at any stage of the subsequent process. Reservation is available for Persons with Benchmark Disabilities (PwBD) under Section 34 of "The Rights of Persons with Benchmark Disabilities Act, 2016". As the reservation for PwBD candidates are on horizontal basis, the selected candidates will be placed in the appropriate category to which the candidate belongs.
- Relaxations are provided to the candidates belonging to SC, ST, OBC and for Persons with Disabilities (PwBDs) category. As per DOPT circular no. 36034/2/2013 dated April 08, 2013, in direct recruitment by way of All India Competitive Examination, the maximum relaxation of 5 years in upper age limit is allowed to Ex-servicemen for appointment in Group A (i.e., Officers cadre).
- Only such persons would be eligible for reservation in services / posts under PwBD category who suffer from not less than 40% of relevant disability.
- For candidates belonging to OBC category, certificate should specifically contain a clause that the candidate does not belong to creamy layer section and is excluded from the benefits of the reservation for other backward classes in civil posts and services under Government of India. OBC caste certificate containing the non-creamy layer clause should be valid as on the last date of applying (issued within one year prior to the last date for applying). Caste name mentioned in certificate should tally letter by letter with Central Government list/notification.
- Candidates belonging to OBC category but coming under creamy layer and/or if their caste does not find place in the Central List are not entitled to OBC reservation.
- The selected candidates will be posted anywhere in India, depending on the requirement of the Bank. Therefore, only candidates willing to serve anywhere in India should apply.
- Selected candidates may also be transferred to offices outside India with their consent.
- Management Trainees will be absorbed in Grade/Scale Junior Management (JM I) as Deputy Manager, after successful completion of training period for one year in the Bank. A monthly stipend of ₹ 55,000/- will be paid during the period of training. The pay band for Deputy Managers (JM-I) appointed in the service of the Bank shall be (₹ 36000 -1490 46430 -1740 49910 1990 63840) as per the Indian Banks' Association (IBA) 11<sup>th</sup> Bipartite Settlement. The current CTC of Deputy Manager works out to ₹ 17.00 lakh per annum approximately.

- The pay band for Managers (MM-II) appointed in the service of the Bank shall be (₹ 48170 -1740 - 49910 -1990 - 69810) as per the Indian Banks' Association (IBA) 11<sup>th</sup> Bipartite Settlement.
- All the educational qualifications mentioned above should be from a University / Institution / Board recognized by Govt. of India / approved by Govt. Regulatory Bodies. In case the date of passing is not properly mentioned in the mark- sheet or provisional certificate, proper document from Board / University indicating the date of declaration of results has to be submitted at the time of interview. In case the result of a particular examination is posted on the website of the University / Institute and webbased certificate is issued, then proper document / certificate in original issued and signed by the appropriate authority of the University / Institute indicating the date of passing that examination properly mentioned thereon will be reckoned for verification and further process.
- Upon absorption of Management Trainees as Deputy Managers after successful completion of traineeship of one year, in addition to the pay, the selected candidates will be eligible for allowances, perquisites and benefits, as applicable to the Grade as per Bank's rules, prevalent at the time of joining. Residential accommodation may be provided subject to availability or alternatively leased accommodation scheme is in place. Schemes for granting loans for housing, vehicle, personal computer, children education etc. are also available.
- Only those who satisfy the required age and qualification should apply.
   Applications that do not meet with the requirements will be rejected and no correspondence in this regard will be entertained.

Only Online Applications will be considered by the Bank. Canvassing in any form will be a disqualification.
- Application fees and intimation charges (Non-refundable) are ₹ 600/- for OBC candidates and ₹ 100/- (Intimation charges) for SC/ST/ PwBD /EWS and Female candidates. Applicants are requested to ensure their eligibility before applying for any post. Fees once paid will not be refunded in case the applicant is not found to be eligible for the said post.
- The Selection Process will comprise of Online Test comprising of objective and descriptive type questions and Personal Interview. The date and timing of the Online test will be advised to the eligible candidates at a later date by notification on our website, personal email and/or SMS. Candidates who are shortlisted based on the performance in the Online Test will be called for Personal Interview.

- Depending upon the requirement and suitability of the candidates, the Bank reserves the right to cancel/restrict/curtail/enlarge the recruitment process including the number of vacancies, if need so arises, without any further notice and without assigning any reason therefor.
- No correspondence will be entertained from any ineligible and non-selected candidate. In all matters regarding eligibility, the selection process, the stages at which the scrutiny of eligibility is to be undertaken, documents to be produced for the selection process, assessment, prescribing minimum qualifying standards in the selection process, number of vacancies, communication of results, etc., the Bank's decision shall be final and binding on the candidates and no correspondence shall be entertained in this regard.
- Selected candidates, who are already in service must produce a proper relieving letter / discharge certificate in original from their present employer at the time of joining, failing which they shall not be allowed to join the Bank.
- Candidates who have defaulted in any loan repayment and / or their name appear in CIBIL database as defaulter, are not eligible to join the Bank.
- Selected candidates (Management Trainees), at the time of joining the Bank, will have to execute a personal bond for ₹ 3.00 lakh to serve the Bank for one year as Management Trainee from the date of joining the Bank and minimum of 5 years as employee from the date of absorption of in the Bank's service.
- Selected candidates (Managers), at the time of joining the Bank will have to execute a personal bond for ₹ 3.00 lakh to serve the Bank for a minimum period of 3 years, from the date of joining the Bank.
- Any legal proceedings in respect of any matter of claim / dispute arising out
  of this advertisement and / or an application in response thereto can be
  instituted only in Mumbai and courts / tribunals / forums at Mumbai only

- The Bank reserves the right to cancel the recruitment process entirely at any stage.

## ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT / USE OF UNFAIR MEANS

Candidates are advised in their own interest that they should not furnish any particulars that are false, tampered with or fabricated and should not suppress any material information while submitting application. At the time of examination, interview or in a subsequent selection procedure, if a candidate is (or has been) found guilty of:

- (i) Using unfair means
- (ii) Impersonating or procuring impersonation by any person, OR
- (iii) Misbehaving in the examination/interview hall or disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of contents of the test(s) or any information therein in whole or part thereof in any form or by any means, verbal or written, electronically or mechanically for any purpose, OR
- (iv) Resorting to any irregular or improper means in connection with his/ her candidature, OR
- (v) Obtaining support for his/ her candidature by unfair means, OR
- (vi) Carrying mobile phones or similar electronic devices of communication in the examination/ interview hall.

Such a candidate may, in addition to rendering himself/ herself liable to criminal prosecution, shall be liable;

- a) to be disqualified from the examination for which he/ she is a candidate:
- b) to be debarred either permanently or for a specified period from any examination conducted by the Bank.
- c) for termination of service, if he/ she has already joined the Bank.

## **GENERAL INSTRUCTIONS TO CANDIDATES:**

CANDIDATES REPORTING LATE i.e., after the reporting time specified on the call letter for Examination will not be permitted to take the examination. The reporting time mentioned on the call letter is prior to the Start time of the test. Though the duration of the examination is 3 hours, candidates may be required to be at the venue for about 4 hours including the time required for completion of various formalities such as verification and collection of various requisite documents, logging in, giving of instructions, etc.

#### **IDENTITY VERIFICATION**

In the examination hall as well as at the time of interview, the call letter along with original and a photocopy of the candidate's currently valid photo identity (bearing exactly the same name as it appears on the call letter) such as PAN Card/ Passport/ Permanent Driving License/ Voter's Card/ Bank Passbook with photograph/ Photo identity proof issued by a Gazetted Officer on official letterhead along with photograph / Photo identity proof issued by a People's Representative on official letterhead along with photograph / valid recent Identity Card issued by a recognized College/ University/ Aadhar card/ E-Aadhar Card with a photograph/ Employee ID/ Bar Council Identity Card with photograph should be submitted to the invigilator for verification. The candidate's identity will be verified with respect to his/her details on the call letter, in the Attendance List and requisite documents submitted. If identity of the candidate is in doubt the candidate may not be allowed to appear for the Examination.

Ration Card and Learner's Driving License are **not** valid id proof.

Note: Candidates must produce in original the photo identity proof and submit photocopy of the photo identity proof along with Examination call letter as well as the Interview Call Letter while attending the examination/ interview respectively, without which they will not be allowed to take up the examination/ interview. Candidates must note that the name as appearing on the call letter (provided during the process of registration) should exactly match the name as appearing on the photo identity proof. Female candidates who have changed first/last/middle name post marriage must take special note of this. If there is any mismatch between the name indicated in the Call Letter and Photo Identity Proof the candidate will not be allowed to appear for the examination. In case of candidates who have changed their name, will be allowed only if they produce original Gazette notification / their original marriage certificate / affidavit in original.

#### **INFORMATION ON EXAMINATION CENTRES:**

- 1. The examination will be conducted online at venues given in the respective call letters.
- 2. No request for change of centre/venue/date/session for Examination shall be entertained.
- 3. Export-Import Bank of India, however, reserves the right to cancel any of the Examination Centres and/ or add some other Centres, at its discretion, depending upon the number of candidates, administrative feasibility, etc.

- 4. Export-Import Bank of India also reserves the right to allot the candidate to any Centre other than the one he/she has opted for.
- 5. Candidate will appear for the examination at an Examination Centre at his/her own risks and expenses and Export-Import Bank of India will not be responsible for any injury, expense or losses etc. of any nature.
- 6. Choice of centre once exercised by the candidate will be final.

If sufficient number of candidates do not opt for a particular centre for "Online" examination, OR if the number of candidates is more than the capacity available for online exam for a centre, Export-Import Bank of India reserves the right to allot any other centre to the candidate.

#### PROCESS FOR ARRIVING AT SCORES

The Scores of Online Examination are obtained by adopting the following procedure:

- (i) Number of questions answered correctly by a candidate in each objective test is considered for arriving at the Corrected Score after applying penalty for wrong answers.
- (ii) The Corrected Scores so obtained by a candidate are made equivalent to take care of the minor difference in difficulty level, if any, in each of the objective tests held in different sessions to arrive at the Equated Scores\*

<sup>\*</sup> Scores obtained by candidates on any test are equated to the base form by considering the distribution of scores of all the forms.

(ii) Test wise scores and scores on total is reported with decimal point upto two digits.

Note: Cutoffs are applied in two stages:

ii. on scores in individual tests

ii. on Total Score

#### OTHER IMPORTANT INFORMATION (FOR ALL VACANCIES)

- 1. The possibility of occurrence of some problem in the administration of the examination cannot be ruled out completely which may impact test delivery and/or result from being generated. In that event, every effort will be made to rectify such problem, which may include movement of candidates, delay in test. Conduct of a re-exam is at the absolute discretion of test conducting body. Candidates will not have any claim for a re-test. Candidates not willing to move or not willing to participate in the delayed process of test delivery shall be summarily rejected from the process.
- 2. Decision of Export-Import Bank of India in all matters relating to recruitment will be final and binding on the candidate. No correspondence or personal enquiries shall be entertained by the Export-Import Bank of India in this behalf.
- 3. If the examination is held in more than one session, the scores across various sessions will be equated to adjust for slight differences in difficulty level of different test batteries used across sessions. More than one session is required if the nodes capacity is less, or some technical disruption takes place at any center or for any candidate.
- 4. Export-Import Bank of India would be analysing the responses (answers) of individual candidates with those of other candidates to detect patterns of similarity of right and wrong answers. If in the analytical procedure adopted by Export-Import Bank of India in this regard, it is inferred/ concluded that the responses have been shared and scores obtained are not genuine/ valid, Export-Import Bank of India reserves the right to cancel the candidature of the concerned candidates and the result of such candidates (disqualified) will be withheld.
- 5. Answers to descriptive questions will be checked only for those candidates who secure minimum qualifying marks in Objective test as determined by the Bank. Decision of Export-Import Bank of India in this respect shall be final.
- 6. There will be no sectional cut off but the final list for interviews will be drawn based on the candidate's performance in Descriptive test answers and numbering upto 5 times (10 approx.) of the respective category wise merit list subject to a candidate scoring the minimum aggregate qualifying score, as decided by the Bank at a later stage.

- 7. Final list shall be drawn based on overall performance of the candidate in Written examination and interviews. The marks obtained in Descriptive, examination out of [100 with 80% weightage] and Interview [Out of 100 with 20% weightage] shall form the basis for final selection.
- 8. Candidates shall be required to undergo Psychometric test conducted by the Bank before appearing for the interview. No mark shall be allotted for the same.
- 9. Instances for providing incorrect information and/or process violation by a candidate detected at any stage of the selection process will lead to disqualification of the candidate from the selection process and he/she will not be allowed to appear in any recruitment process of Export-Import Bank of India in the future. If such instances go undetected during the current selection process but are detected subsequently, such disqualification will take place with retrospective affect.
- 10. A pre-recruitment training will be organised for the candidates from reserved categories. Details of the training and its mode of delivery (online / offline) will be intimated to the candidates who opt for it through the online application form. Details will be shared with such candidates after the last date of registration.

#### **GUIDELINES FOR PERSONS WITH DISABILITIES USING A SCRIBE**

Candidates whose writing speed is adversely affected permanently for any reason can use their own scribe at their cost during the online examination. In all such cases where a scribe is used, the following rules will apply:

- The candidate will have to arrange his/her own scribe at his/her own cost.
- The scribe arranged by the candidate should not be a candidate for the same examination. If violation of the above is detected at any stage of the process, candidature of both the candidate and the scribe will be cancelled. Candidates eligible for and who wish to use the services of a scribe in the examination should invariably carefully indicate the same in the online application form. Any subsequent request may not be favourably entertained.
- A person acting as a scribe for one candidate cannot be a scribe for another candidate.
- The scribe may be from any academic stream.
- Both the candidate as well as scribe will have to give a suitable undertaking confirming that the scribe fulfils all the stipulated eligibility criteria for a scribe mentioned above. Further in case it later transpires that he/she did not fulfil any laid down eligibility criteria or suppressed material

facts the candidature of the applicant will stand cancelled, irrespective of the result of the online examination.

- Those candidates who use a scribe shall be eligible for compensatory time of 20 minutes for every hour of the examination or as otherwise advised.
- Scribe should not answer on his/her own. Any such behaviour observed will result in cancellation of candidature.
- Only candidates registered for compensatory time will be allowed such concessions since compensatory time given to candidates shall be system based, it shall not be possible for the test conducting agency to allow such time if he / she is not registered for the same. Candidates not registered for compensatory time shall not be allowed such concessions.
- During the exam, at any stage, if it is found that scribe is independently answering the questions, the exam session will be terminated, and candidate's candidature will be cancelled. The candidature of such candidates using the services of a scribe will also be cancelled if it is reported after the examination by the test administrator personnel that the scribe independently answered the questions.

## <u>Guidelines for Candidates with locomotor disability and cerebral palsy</u>

A compensatory time of twenty minutes per hour or otherwise advised shall be permitted for the candidates with locomotor disability and cerebral palsy where dominant (writing) extremity is affected to the extent of slowing the performance of function (minimum of 40% impairment).

## **Guidelines for Candidates with Visual Impairment**

Visually Impaired candidates (who suffer from not less than 40% of disability) may opt to view the contents of the test in magnified font and all such candidates will be eligible for compensatory time of 20 minutes for every hour or otherwise advised of examination.

These guidelines are subject to change in terms of GoI guidelines/ clarifications, if any, from time to time.

#### IMPORTANT POINTS TO BE NOTED BEFORE REGISTRATION

Before applying online, candidates should

#### (i) Scan their:

- Photograph (4.5cm  $\times$  3.5cm)
- Signature (with black ink)
- Left thumb impression (on white paper with black or blue ink)
- A handwritten declaration (on a white paper with black ink) (text given below)
  - Ensuring that all these scanned documents adhere to the required specifications as given in Annexure III to this Advertisement.
- (ii) Signature in CAPITAL LETTERS will NOT be accepted.
- (iii) The left thumb impression should be properly scanned and not smudged. (If a candidate is not having left thumb, he/she may use his/ her right thumb for applying.)
- (iv) The text for the handwritten declaration is as follows –

  "I, \_\_\_\_\_ (Name of the candidate), hereby declare that all the information submitted by me in the application form is correct, true and valid. I will present the supporting documents as and when required."
- (v) The above-mentioned handwritten declaration has to be in the candidate's handwriting and in English only. If it is written and uploaded by anybody else or in any other language, the application will be considered as invalid.
- (vi) Keep the necessary details/documents ready to make Online Payment of the requisite application fee/ intimation charges.
- (vii) Have a valid personal email ID and mobile no., which should be kept active till the completion of this Recruitment Process. Bank may send intimation to download call letters for the Examination etc. through the mentioned e-mail ID and / or SMS. In case a candidate does not have a valid personal e-mail ID, he/she should create his/her new e-mail ID and mobile no. before applying on-line and must maintain that email account and mobile number.

## A. Application Registration

A Provisional Registration Number and Password will be generated by the system and displayed on the screen. Candidate should note down the Provisional Registration Number and Password. An Email & SMS indicating the Provisional Registration number and Password will also be sent.
- 3. In case the candidate is unable to complete the application form in one go, he / she can save the data already entered by choosing "SAVE AND NEXT" tab. - Look straight at the camera with a relaxed face
- If the picture is taken on a sunny day, have the sun behind you, or place yourself in the shade, so that you are not squinting and there are no harsh shadows
- If you have to use flash, ensure there's no "red-eye"
- If you wear glasses make sure that there are no reflections, and your eyes can be clearly seen.

- Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
- Dimensions 200 x 230 pixels (preferred)
- Size of file should be between 20kb-50 kb
- Ensure that the size of the scanned image is not more than 50kb.
   If the size of the file is more than 50 kb, then adjust the settings of the scanner such as the DPI resolution, no. of colours etc., during the process of scanning.

## Signature, left thumb impression and hand-written declaration Image:

- The applicant has to sign on white paper with Black Ink pen.
  - Dimensions 140 x 60 pixels (preferred)
  - Size of file should be between 10kb 20kb for signature and 20kb - 50kb for left thumb impression.
  - Ensure that the size of the scanned image is not more than 20kb
- The applicant has to put his left thumb impression on a white paper with black or blue ink.
  - File type: jpg / jpeg
  - Dimensions: 240 x 240 pixels in 200 DPI (Preferred for required quality) i.e., 3 cm \* 3 cm (Width \* Height)
  - File Size: 20 KB 50 KB
- The applicant has to write the declaration in English clearly on a white paper with black ink.
  - File type: jpg / jpeg
  - Dimensions: 800 x 400 pixels in 200 DPI (Preferred for required quality) i.e., 10 cm \* 5 cm (Width \* Height)
  - o File Size: 50 KB 100 KB
- The signature left thumb impression and the handwritten declaration should be of the applicant and not by any other person.
- If the Applicant's signature on the attendance sheet or Call letter, signed at the time of the examination, does not match the signature uploaded, the applicant will be disqualified.
- Signature / Handwritten declaration in CAPITAL LETTERS shall NOT be accepted.
- Illegible, unclear, smudged declaration will be rejected. Candidates must ensure that the declaration is clear and readable.

#### Scanning the documents:

- Set the scanner resolution to a minimum of 200 dpi (dots per inch)
- Set Colour to True Colour
- File Size as specified above
- Crop the image in the scanner to the edge of the photograph/signature/ left thumb impression / handwritten

- declaration, then use the upload editor to crop the image to the final size (as specified above).
- The image file should be JPG or JPEG format. An example file name is: image01.jpg or image01.jpeg. Image dimensions can be checked by listing the folder files or moving the mouse over the file image icon.
- Candidates using MS Windows/MSOffice can easily obtain documents in .jpeg format by using MS Paint or MSOffice Picture Manager.
