**32 YEARS FOR PROJECT ENGINEERS AND 28 YEARS FOR TRAINEE ENGINEERS AS ON 01.03.2024**

The above mentioned upper age limit is for General & EWS candidates. The age limit will be relaxable by 03 years for OBC candidates and by 05 years for SC & ST candidates. Candidates belonging to PwBD category, having minimum 40% disability or more will get 10 years' age relaxation in addition to the relaxation applicable to the categories mentioned above.

**2.0 TERMS OF ENGAGEMENT AND ALLOWANCES:**

**Project Engineer - I** will be engaged for an initial period of 03 years, which may be extended up to maximum of One year (Maximum tenure of 04 years) based on project requirement and individual performance. Candidates will be paid a consolidated remuneration of Rs.40,000/- per month for the 1<sup>st</sup> year, Rs.45,000/- for 2<sup>nd</sup> year, Rs.50,000/- for 3<sup>rd</sup> year and in the event of extension of contract Rs.55,000/- for the 4<sup>th</sup> year.

**Trainee Engineer - I** will be engaged for an initial period of 02 years, which may be extended up to maximum of One year (Maximum tenure of 03 years) based on project requirement and individual performance. Candidates will be paid a consolidated remuneration of Rs.30,000/- per month for the 1<sup>st</sup> year, Rs.35,000/- for 2<sup>nd</sup> year and in the event of extension of contract Rs. 40,000/- for the 3<sup>rd</sup> year.

- The minimum qualifying marks in Written Test and Interview is 35% for General/EWS/OBC and 30% for SC/ST/PwBD.
- The venue for the Written Test and Interview will be intimated later.

You have to select the SBI branch in the payment option and download the pre-printed challan generated through SBI Collect and deposit the application fee (as applicable) plus applicable bank charges in any SBI Branch. The candidate should ensure to obtain the Seal and Signature of the Bank Official.
- c) General, OBC and EWS candidates have to enter the “SBI Collect Reference Number” generated after payment, in the Application Form and attach the challan along with the application. SC/ST/ PwBD candidates are exempted from payment of application fee.
